## Costs and Limitations for Regulatory Compliance Platform Version 1.2

### Capability and Description

2015 Edition criteria applicable to Eye Care Leaders Regulatory Compliance Platform Version 1.2: b6, c1, d1, d2, d3, d5, d6, d7, d8, d9, f2, g2, g4, g5, g6, g7, g8, g9

The Regulatory Compliance Platform Version 1.2 is a cloud-based modular application that when used in combination with other Health IT Modules forms a complete CEHRT solution for healthcare professionals in ophthalmology and optometry in outpatient ambulatory environments. It allows users to perform a wide range of functions such as:

- Monitor MIPS Performance and provide Meaningful Use Reporting for the Medicaid EHR Incentive Program for EPs.
- · Report information to PHAs (public health agencies) and clinical data registries and allow integration with APM entities.
- Create "gold standard" electronic health information documents required for referrals, transitions of care and to share with the
  patient
- Send/receive messages and attached documents to/from the HISP via Direct Edge Protocol.
- Provides an API to allow patients to access their health information via third party applications
- Bulk export of CCD files

### Types of Costs or Fees and Additional Types of Costs or Fees

There is no additional cost associated with the Regulatory Compliance Platform Version 1.2 and is provided as part of a complete CEHRT solution in conjunction to the EHR (electronic health record)

# Limitations (Contractual/Business)

The Regulatory Compliance Platform Version 1.2 is used as part of an EHR solution package and is subject to the same contractual limitations as the specific EHR that is chosen by the client. Only EHRs that are within the Eye Care Leaders line of Health IT products may integrate with the Regulatory Compliance Platform Version 1.2

### Limitations (Technical/Practical)

The Regulatory Compliance Platform Version 1.2 provides Direct Edge Protocol via interface with a third party HISP.

The Regulatory Compliance Platform Version 1.2 is reliant on and integrates with PopHealth for CQM calculation and QRDA III reporting. The end user cannot access the PopHealth dashboard directly through the Regulatory Compliance Platform.

This Health IT Module is 2015 Edition compliant and has been certified by an ONC-ACB in accordance with the applicable certification criteria adopted by the Secretary of the U.S. Department of Health and Human Services.
